ESCROWED LICENSES

- **Fiddleheads**, 4313 W. Thirteen Mile Rd.- No pending transfer on record
- **Leo's Bar & Grill #2**, 112 S. Main – This license is for Midtown Parthenon. The applicant is in the process of requesting a Plan of Operation change to go from a Greek restaurant to a French restaurant called "Tres Joli."
- **Rumors**, 112 S. Main – MLCC transfer pending (Applicant- Dino Ciccarrelli, 409 S. Center, "Ballentine 22").
- **Small Plates**, 310 S. Main – MLCC transfer pending (Applicant-JJT Hospitality, LLC- 526 S. Main, "526 Tequila Blue").

BISTRO'S

- **7 One. One Bistro**, 711 S. Main – Requested Plan of Operation change.

APPROVED LICENSE

- **Emagine Theater**, N W corner of Eleven Mile and N. Troy – Pending completion of construction.

PENDING LICENSE APPLICATIONS

- **Ballantine 22**, 409 S. Center- License transfer request from Rumors (112 S. Main). The applicant is Dino Ciccarrelli. The investigation has been completed and will be on the November 10, 2010 LCC Meeting agenda. The square footage is 9,600 on one (1) floor. The dining seating capacity will be 128 seats, which includes 25 bar seats. A "pizza bar" (no alcohol) located south of the main bar will seat 8 patrons. The banquet area will consist of four (4) sections. Banquet A will seat 96 patrons, Banquet B will seat 48


seats, Banquet C will seat 32 patrons and Banquet D will seat 14 patrons. Additionally, the banquet area has a bar which seats 9 patrons. Total seating for the banquet area will be 199 seats, which includes 9 bar seats.

The total seating capacity for this establishment will be 357.

- **Royal Oak Golf Course**, 3417 Don Soper – New Class C request. This investigation has not been completed by our department. I am awaiting supplemental documents from the applicants. Square footage and seating capacity is not known at this time.
- **526 Tequila Blue**, 526 S. Main- License transfer request from Small Plates (310 S. Main). The applicants are Tony Kasab, James A. Harvey and Jerrold Jung. The investigation has been completed and will be on the November 10, 2010 LCC Meeting agenda. Square footage is 9,000 on two (2) floors. Requested seating capacity is 101 patrons, which includes 13 bar seats, on the first floor. The second floor seating capacity will be 172 patrons, which includes 18 bar seats. The outside seating will be for 60 patrons.

The total seating capacity for this establishment will be 333.
