## Armed Robbery:

**Serv Rite Liquor Store, 4304 Rochester Rd., 04/26/10, 9:25 pm:** The store clerk was approached by a white male wearing a "Joker" face mask and dressed in all black clothing. The gunman pointed a black semi-automatic handgun at the clerk and demanded all the money. The clerk handed over an undisclosed amount of cash, and the suspect fled the store on foot. *This suspect has been arrested and charged with armed robbery.* 10-1697
